- 2. Candidate should have relevant work experience in rural development sector not exceeding 2 years in total from the date of attaining the qualifying degree.
- 3. Candidates must have worked with government led large poverty reduction programme or reputed NGOs/CSOs working at considerable scale and size.

4. Candidates must have worked with poor community at grassroots level and experience of forming community institutions.

General Instructions:

- 1. The offered remuneration for the above position is Rs 25,000 pm. The other benefits shall be applicable as per JSLPS HR policy for YPs.
- 2. Reservation Policy of Govt. of Jharkhand will be applicable. Reservation benefits will only be available to the domiciled residents of Jharkhand.
- 3. Number of posts can be increased or decreased as per the requirement. .
- 4. At any stage of recruitment, it is found that candidate does not fulfill the eligibility criteria and/or that he/she has furnished incorrect/false information/certificate/documents or has suppressed any material fact(s), his/her candidature/appointment will stand cancelled and necessary legal action will be initiated.

- 6. The selection process will include Written Test, Group Discussion and Personal Interview or as decided by department.
- 7. All Positions are offered on a contract basis for two years, Contract is renewable every year based on review of performance and requirement of project.
- 8. Resume & Photocopies of all certificates in two sets related to education/professional degree needed to be produced at the time of "Walk in Selection process". Candidates are instructed to download CV format from JSLPS website and appear in the selection process with all required documents
