WALK-IN-INTERVIEW

The Medical Superintendent, E SIC Hospital, Namkum, Ranchi proposes to conduct a walk-in interview for Full Time/Part Time contractual Specialist (for a tenure of one year on contract basis/till joining regular incumbent whichever is earlier). The walk-in interview shall be conducted on 15th of every month being a working day or on the next working day, till the vacancies get filled up.

Qualification

PG Degree/DNB or Diploma in concerned specialty from recognized University with three (03) years' experience after Post Graduate Degree/DNB and five (05) years' experience after Diploma.

Emoluments

- A. Full Time Specialist- Basic Pay 18,750/- + Grade pay Rs.6, 600/- + allowances as admissible to Central Government employees or as per orders issued by ESIC Hqrs office from time to time.
- B. Part Time Specialist Remuneration Rs.60,000/- per month for 4(Four) hours session per day for 4 days in a week. Additional Rs.12,000/- admissible if willing to perform emergency call duty.

Age

- A. Full Time Specialist Not exceeding 45 years on the date of interview (Relaxation for SC/ST/OBC/PH/Ex-serviceman as per rules)
- B. Part Time Specialist Age not exceeding 64 years as 0n the date of interview (Relaxation for SC/ST/OBC/PH/Ex-serviceman as per rules)

• The eligible and desiring candidates fulfilling the educational qualifications/eligibility conditions should submit their applications(as per Annexure-'A') along with Two set of self-attested copies of relevant documents in support of age, qualifications, Mark-sheet, degree, MCI/ State Registrations, SC/ST/OBC (non-creamy layer), PH certificate & experience certificate etc. and 2(two) recent passport Sized photographs. The candidate who is currently in the employment must bring experience certificate (working certificate) and NOC failing which his/her candidature will be liable for rejection.

The interview is scheduled on 15th of every month being a working day or on the next working day, till the vacancies get filled up.

- Documents will be accepted for scrutiny strictly till 10.00 A.M. only eligible candidates will be called for interview.
- Reporting Time for Interview:-9:00AM Verification of documents:- 09:00AM to 10:00AM
- · Timing of Interview:-10:00AM onwards

Note: Selected candidates have to report for duty immediately or the date mentioned in offer letter, failing which it will be presumed that they are not interested in joining and their appointment will be deemed to be considered as cancelled without any correspondence in this regard.

TERMS AND CONDITIONS:

- 1. The number of vacancies may be changed without any prior notice.
- 2. No TA/DA will be admissible either for the 'Walk- in- interview' or for joining the post.
- 3. The Competent Authority reserves the right to fill up all or not to fill up any post.
- 4. Selected candidates will have no claim for regularization of the service in the hospital.
- 5. The selected candidates will have to join within 07 days from the date of receipt of the Selection order.
- 6. The selected candidate will have to furnish a DD for an amount of Rs. 30,000/-(Rupees Thirty Thousand Only) drawn in favour of 'ESIC A/c No 1' payable at Ranchi, towards security deposit. However, this amount will be appropriated towards administrative cost in case, the candidate resigns/terminates his/her contract within Nine months of the commencement of the contract with or without prior notice and without one month's notice thereafter.
- 7. The selection is subject to the candidates proving their medical fitness & verification of their Character & Antecedents.
- 8. Private practice is strictly not allowed. If found guilty, suitable action as provided under the relevant rules shall be taken.
- 9. The appointment shall not confer any right or preference for regular appointment.
- 10. No claim for any service benefit like, PF, Pension, Gratuity, medical Allowance, Seniority, Promotion and leave will be admissible.
- 11. Two days leaves per month will be admissible computed at pro rata basis.
- 12. The Medical Superintendent reserves the right to alter the date or cancel the interview.
- 13. Candidates must be registered with State Medial Council or MCI before joining the post
- 14. The candidate who is in the Government Service should submit "No Objection Certificate" from the employer at the time of interview.
- 15. Candidate seeking reservation benefits for SC/ST/OBC/PH must ensure that they are entitled to such reservations per eligibility prescribed in the Notice. They should also be in possession of the required certificates in the prescribed format in support of their claim as stipulated in this Notice. OBC candidates should ensure that they are in possession of valid OBC Certificate issued within the due date issued by the authority mentioned in the format.
- 16. The candidate claiming reservation / age relaxation on grounds of belonging to OBC should submit the community Certificate in proforma prescribed vide Govt. Of India, Department of Personnel

- reservation / relaxation will not be given or their application shall be rejected and no request/ correspondence will be entertained. Certificates issued in other format will not be accepted and the candidates will be treated as "General Category' for all purpose.
- 17. All the posts are purely contractual in nature for a period of one year or till the regular incumbent joins or the lapse of tenure of the post, whichever is earlier. The engagement may be terminated at any time by either side giving one month notice or one month emoluments in lieu of the notice period.
- 18. The candidates are advised to bring their application/Bio data and original certificates.
- All the candidates are directed to report in the office of the Medical Superintendent ESIC Model Hospital, Namkum, Ranchi as per the timing prescribed.
- 20. The decision of the selection board will be final on all aspects of selection and no further correspondence will be entertained under any circumstance.
- 21. The tenure is for a maximum period of one year for full time contractual/Part Time specialist or the regular specialist joins whichever is earlier.

22. The candidates shall be governed by the relevant Rules and Regulations adopted by the ESIC in this regard.
