The posts are initially for a period of one year and may be extended based on the availability of fund and subject to project need.

3. Application Submission:

4. Application Fee:

On-line application fee for the post is INR. 100/-- (One hundred only), which may be paid via On-line Payment Gateway.

5. Submission of application in the recruitment portal

Applications can be submitted on the recruitment portal from 00:00 hours, 11th June 2021 till 23:59 hours, 26th June 2021 only.

6. Selection Process:

Selection for the post of Consultants will be through interview.

- Interview will be conducted by a Committee. Candidates will be offered job against vacant posts in order of merit category wise.
- Applicant must carry original documents of educational qualifications, work experience, salary certificate and other relevant certificates along with valid ID proof including Aadhaar/PAN during the document verification process.
- Final result will be published on the website and a separate notification will be sent to selected candidates only.
