'Relevant experience/ Experience' means experience related to the area of the post advertised. Scrutiny committee will determine relevancy of experience and its decision will be final and binding.

Applicants who have submitted experience certificate, mentioning the pay scales other than Central Govt. Pay Scales/ CDA pattern, should mandatorily submit pay scale equivalence certificate issued from their employer for consideration of their experience. Else, experience would not be considered.
